Law on the Prevention of Domestic Violence against a Spouse or Partner

Act on the Prevention of Spousal Violence and the Protection of Victims, etc.

- In every prefecture in Japan and Kyoto City, Spousal Violence Counseling and Support Centers have been established. These centers offer assistance through consultation and provision of various kinds of information that help DV victims attain safety and self-sufficiency, and also provide temporal protection for those needing shelter.
- Through application at the Court, a restraining order can be issued, which will prohibit the perpetrator from approaching the victim.
- This law protects all people in Japan regardless of nationality or status of residence (not just Japanese citizens or residents but also all individuals from overseas). It is not limited to spouses, but also applies to other intimate partners, such as former spouses, dating partners, domestic partners, and so forth.



The Cabinet Office has a website providing information on support for victims of domestic violence in a spousal or intimate relationship.

What happens to my status of residence if I separate or divorce from my spouse?

- Even if you get divorced, your status of residence will not be revoked until its expiration date. However, after your divorce, you must submit the required "Notification concerning the spouse" to the Immigration Bureau of Japan or its regional office (within 14 days after divorce) and apply for permission to change your status of residence (within 6 months after divorce).
- Even if you get divorced, if you are raising a child that you had with a Japanese citizen, you can apply for "long-term resident" status.
- Even if you get divorced and do not have a child, depending on the length and conditions of your marriage, you could still be granted "long-term resident" status.
- Even if you have overstayed your visa, you may still be granted status of residence by "special permission for residence" if you are being married or if you have a child with a Japanese. "For details on the above information, please consult the Immigration Bureau of Japan or its regional office. (Please refer to the section for consultation and assistance services.)
- If you know of anyone suffering from domestic violence, please give them information on where to get help.
- If the victim wants to get help but cannot make a phone call, please call or make contact on behalf of them.

No one needs to put up with violence even from a spouse or intimate partner.

Don't bear it alone.

Ask for help.

You want to leave but don't know where to go, or worry about getting caught even in the event you try to run away. Or maybe you are putting up with it for your children's sake. If you are worrying all alone, the situation will not change. And the violence might get worse. For your safety, get help as soon as possible.

Physical violence is not the only form of violence that exists. Violence can come in many different forms such as intimidation, verbal and non-verbal threats, and emotional abuse - for example, your spouse or partner is not cooperating with you in renewing your visa, threatening to capture you if you run away, and showing contempt for your way of thinking or lifestyle. If a person is continuously abused, they tend to have feelings of despair and helplessness, and to lose their confidence and will to live as well as their ability to make a sound judgement.

If you have ever felt like you want to escape, don't hesitate to seek help.



In addition to the Law on the Prevention of Domestic Violence against a Spouse or Partner, there are a variety of laws and systems to help victims obtain protection and attain self-sufficiency. Seek consultation from professional organizations to acquire proper information.

These are organizations which are knowledgeable about problems that foreigners face in Japan, including domestic violence (DV).
