Information About the Subsidy for Early Education and Childcare Fees (New Subsidy No.2 & 3)

1. Necessary Procedures

Those living in Kyoto city, who wish to receive the early education and childcare subsidies for the fees of afterhours childcare at kindergartens or Certified Centers for Early Childhood Education and Care (kindergarten section) or of non-accredited childcare (facility use fee), must first apply for and receive an appropriate certification (New Subsidy No.2 or No. 3 Certification) from Kyoto City in advance. To be eligible to receive the New Subsidy No.2 and No.3 Certification, both parents must have a viable reason to require childcare (such as work or needing nursing care themselves). (New Subsidy No. 2 Certification is for households with 3-5 year-olds, and New Subsidy No. 3 Certification is for municipal tax exempt households with 0-2 year-olds.)

Kyoto City will reimburse (cashback) the amount after it has been paid to the corresponding preschools.

About age ... 3 years old: Children who have reached their 3rd birthday are eligible for a 3-year-olds class from the next April.

3 full years old: Children who have reached their 3rd birthday while in a 2-year-olds class.

Aside from actual non-accredited childcare institutions (not including business-operated childcare services), the following will also fall under the said category: baby hotels, babysitters, non-accredited on-site childcare services, temporary childcare services, sick childcare services and family support services. These benefits will apply solely to subsidy-eligible facilities (including those outside Kyoto City) that meet the standards set by local government regulations. 


- *1 Should you wish to apply after the deadline has past, please make sure to send your application to the above address on or before March 31, 2026 (must not arrive later).
- *2 Please note that if you submit your application by mail, it can only be approved after the date it arrives at the centralized office.
 - Additionally, please write "利用給付認定申請書在中" (Application form for the Certification of the Subsidy for Early Education and Childcare Fees enclosed) on the envelope.
- *3 The applicant is required to be a citizen of Kyoto City on the day of commencing certification process. For those who plan to move in the city, the certification process will be commenced after submittal of a notification of change of address.

4. Upcoming Schedule (Tentative) (for certification starting in April 2026)

- (1) For kindergartens / certified Center for Early Childhood Education and Care (ECEC)
- * Kyoto City will, in principle, not offer reimbursements (cash backs) due to the waiving of subsidy cap amount after-hours childcare fees for municipal kindergartens.
- * Depending on the timing of actual usage reports submitted by the kindergarten, the subject months for payment may vary.

5. What to expect after submitting your application

Should there be any changes in your address (moving within the same city), household composition, reasons for needing childcare or bank account for receiving subsidy, or should there be your leaving or changing of kindergartens, after applying for the Certification of the Subsidy for Early Childhood Education and Childcare Fees, please submit necessary documents including a Change Application Form. You may get ahold of the necessary documents at the Kyoto City Official Website (See 6 below). You may also get them at the "Kodomo Hagukumi" rooms of ward offices and branch offices.

In the case of moving to outside the city, the certification will be withdrawn by Kyoto City on the previous day of moving out. Procedures for withdrawal of the certification are therefore necessary. If you wish to continue to use the kindergarten, you are required to go through the procedure at the local government of your new residence.
