[Matters agreed upon]

1. For the provision of proper educational and day-care services and in order to confirm the data of applicants and their household members, including their tax status for the screening of the Certification of the Subsidy for Early Childhood Education and Childcare Fees, office work related to the Supplementary Benefit Program, and other educational and day care services, we may ask public offices to allow us to view necessary documents or to provided us with related materials.
2. Details entered on your application form, etc. may be provided to the institution and/or its operator when they are deemed necessary as information related to the certification and grant of the Subsidy for Early Childhood Education and Childcare Fees, as well as other educational and day care services.
3. Based on the provision of Article 30-11 of the Child and Child Care Support Act (hereinafter "the Act"), a target institution use charge may be paid to the special child & childcare support provider instead of the guardians who received certification.
4. In the case of starting the use of a target institution in April of new fiscal year, since it takes time for screening, etc. with the concentration of certification work, there may be a case where notification of the screening results may be postponed based on Clause 5, Article 30-5, regardless of the date of application.
5. If your application details differ from the actual facts, the Certification of the Subsidy for Early Childhood Education and Childcare Fees for your application may be canceled.
6. In the case where you have used one of the institutions stipulated in the Cabinet Order 4-c, Clause 10, Article 7 of the Act (company-driven childcare services) as of the desired dates for certification, you cannot receive certification for this subsidy.
7. Guardians of children who use kindergartens and after-hours childcare stipulated in Clause 10-5, Article 7 of the Act must entrust applications related to a target institution use charge to the providers or directors of the institutions (principals of their kindergartens) that they will use, unless the guardians themselves or their institutions make a special request.
