## Attestation and Agreement

\*To be eligible for the Benefit, all of the following requirements relevant to the eligible Benefit must be satisfied.

[Benefit for households exempt from residence tax]

•As of June 3, 2024, a household in which all members are exempt from residence tax for FY2024

[Benefit for households subject to residence tax on a per capita basis only]

•As of June 3, 2024, a household in which all members are exempt from residence tax on an income basis (subject to residence tax on a per capita basis only and exempt from residence tax on an income basis) for FY2024 or household consisting of members subject to residence tax on a per capita basis only and members exempt from residence tax for FY 2024

[Common conditions for both households exempt from residence tax and households subject to residence tax on a per capita basis only]

•No members of the household have income that is subject to residence tax but has not yet been declared.

•Our household is not the same household which was eligible to receive the FY 2023 benefit for households exempt from residence tax (70,000 yen) or benefit for households subject to residence tax on a per capita basis only (100,000 yen) from Kyoto City or other municipalities or does not include the head of such household.

•Our household has not received the benefit for households exempt from residence tax or subject to resident tax on a per capita basis only for FY 2024 (100,000 yen\*) from any municipality other than Kyoto City.

	<p>receiving the Benefit, and it may request necessary documents from, or provide them to, other administrative agencies.</p> <p>(3) In the event that the information cannot be confirmed by the public registry, etc., I will submit the relevant documents.</p> <p>(4) Once Kyoto City has made a decision to provide the Benefit, this application form will be handled as a request form for the Benefit.</p> <p>(5) I attest that if payment cannot be processed due to reasons such as failure of fund transfer because of an incomplete application form (request form) and if a correction is not made by October 31, 2024, the Benefit will not be paid.</p> <p>(6) If I receive the Benefit despite not meeting the requirement (1) or I later do not meet the requirements for receiving the Benefit after receiving the Benefit (including the case that I have become subject to residence tax for FY 2024 by filing of an amended income tax return), I will return the Benefit to Kyoto City.</p> <p>Points to note regarding Additional Benefit for Children</p> <p>In addition to meeting the above requirement, if your household meets the following requirement, your household is eligible to receive the Additional Benefit for Children. An Application Form and Request Form for FY 2024 Kyoto City Livelihood Support Benefit (Additional Benefit for Children) is required to be submitted separately. (As mentioned on the front, an application for children 18 years old or younger who are registered as residents as household members as of June 3, 2024 is not required to be submitted.)</p> <p>(1) You support children 18 years old or younger (born on or after April 2, 2006) who are members of another household</p> <p>(2) You moved out of Kyoto City on or after June 4, 2024 and have children who were born after the move-out.</p>
